

How to Get A Free iPhone

About me

First, I wanna tell you that this is NOT some type of scam. In the next few paragraphs, I will describe to you the process of how to get a free iPhone. This is a very simple process which, if implemented as described, will get you a free iPhone.

The second part of this document is the Program Requirements extracted from the website of the company that offers free iPhones. These 2 parts (mine and the company's) will give you a very good overview of how it works and how easy it is.

Why am I doing this?

One of my co-workers told me a few months ago that he filled out some info online and he was gonna get a free iPhone for it. I was like "yeah right. whatever". I was kinda making fun of him because I never thought he was the type of guy doing this (he's the IT guy so I thought he would know better). But he actually got his free iPhone 2 about weeks ago!! I could not believe it. Now I know that it works, I wanna do the same and get a free iPhone too. and you can get one too.

Why would some companies give away free iPhones?

These companies offering you free stuffs require you to complete some offers. Most of the offers you can choose from are trial periods (= FREE) and most of the offers they want you to sign up for are often useful and legit stuffs such as Netflix, Stamps.com (the one I chose), etc. You only need to sign up for one offer. Once you sign up, they assume that after the trial period, you will keep using the service (Netflix or Stamps.com or whatever you choose), thus paying for it. Netflix (let's say you choose netflix) then pays some type of referral fee to the company. The trick is you have to cancel before the end of your trial period. To get the free iPhone, you need to refer 13 people to do the same thing as you. That's how they make money and can afford to give you a free iPhone.

What is the process?

This is very easy to do! It literally takes 10 minutes to setup (no kidding, 10 minutes). Simply follow the steps below:

1/ [Click on this link](#) (if you click on a different link, it may not work)

2/ Register, pick an account type (I suggest the "referral" account; it is the easiest)

3/ Complete just 1 offer (very important that you complete the 1 offer otherwise your account will sit in limbo until you do). There are plenty of cool offers to choose from such as Blockbuster online, Stamps.com, Netflix, Gamefly, which are services you would regularly sign up for anyways and they are all secure networks, why not use them to get a free iphone! I completed the Stamps.com offer for a 30 day free trial and it never cost me a penny and I received credit for it the same day, you can cancel whenever you want (however I recommend waiting at least a couple weeks before canceling).. After completing the free Stamps.com trial period, they give you a credit of \$5 to print stamps, which I think is pretty cool. Note that if you choose Stamps.com like I did, you need to sign up for the trial period, then you need to download the stamps.com software (took 30 seconds to download), install it and print one stamp! If you choose Netflix or Blockbuster, you don't have anything to download. By the way, I chose the Stamps.com offer as I already have a Netflix account.

4/ After that, your "free iphone" account will be credited and they will generate an [affiliate link like mine](#). You will then need to do like I am doing right now, trying to get 13 people do the same thing. If you have 13 friends willing to do that, good for you. I found out that people are really reluctant to complete that kind of thing. Reason is they think it's a scam. I thought so too. Well, now I've had the proof that this is not a scam that's why I wanna do this. I need to find people like me. There is nothing to lose anyway!

5/ Once you have referred 13 people and once these 13 people have completed 1 offer (like the Stamps.com one), they will ship your iphone. No Joke. The reason these companies make money, is because most people don't bother getting all the referrals. They use us as advertisement by word of mouth which saves them tons of money which goes toward yours and my free gift. These are legit companies such as Blockbuster, Netflix, Gamefly, etc...

Don't try to cheat!

Do not try to have your wife or your roommate sign up because it won't work! Two people living under the same roof cannot complete the offer. They are serious about this. Before sending you the iPhone, they will check you and your referrals!

Individuals found to be abusing or maliciously using the site will be banned immediately and prohibited from rejoining on that site. Individuals found abusing advertisers offer or posting cancellation "walkthroughs," cheats, or items of similar nature will be subject to indefinite suspension from the site.

Again, be legit; don't try to fool the system because they will get you.

This is what I did, step by step

1/ I was referred by someone. I clicked the link they sent me and registered on the website. [Click this link to be referred by me.](#)

Select. Try. Receive

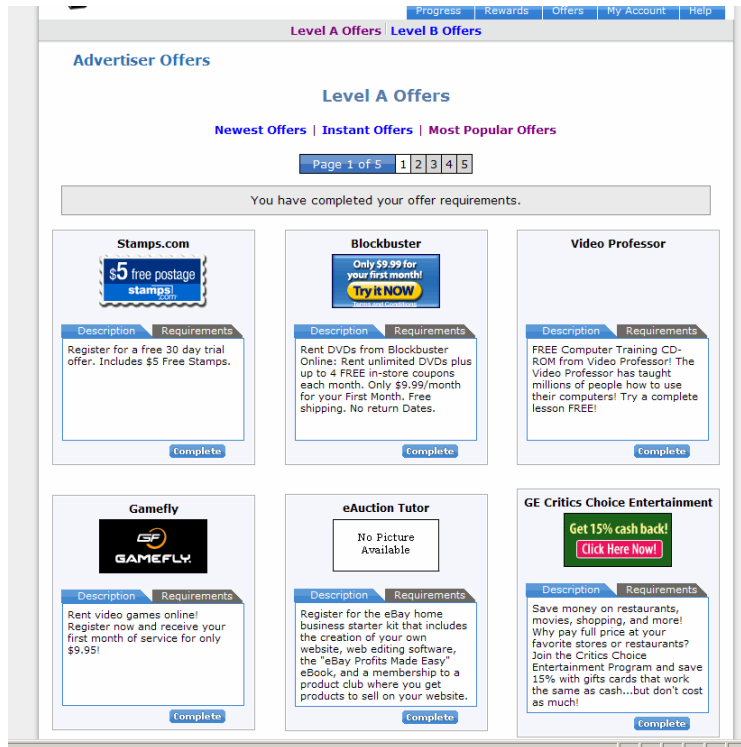

2/ I chose my type of account: referral (as I mentioned earlier, this is the easiest one).

3/ I looked at the various offers they have. They require you to complete one offer. They let you choose between about 50 offers. The 4 main legit offers are Stamps.com, Netflix.com, BlockbusterOnline.com and GameFly.com.



4/ As I already have a Netflix account, I chose Stamps.com, even though I don't need stamps! If you want a free Netflix trial, choose Netflix. If you choose Netflix, make sure you don't already have a Netflix account or it won't work!

5/ I completed the Stamps.com offer. It required me to give them my name, address, phone number, and credit card number. They ask for your credit card number because if you don't cancel before the end of the trial period, they will charge you. So I gave them all the information they needed.

6/ I received a confirmation email from Stamps.com. I downloaded the software. The download took about 30 seconds. I installed the software, opened it and printed a stamp. Note that to activate your account, you need to do all this (download, install, open, and PRINT a stamp). I don't have a printer at home so I simply clicked "print" and it gave me a message saying that I don't have a printer but it works anyway like this. The system just wants you to create a stamp.

7/ I waited about 2 minutes after printing my stamp and went back to the website offering the free iPhone. I saw right away that my account was activated because Stamps.com sent them the information that I printed a stamp, thus activating the process.

8/ This step is actually where I am right now... Now I need people to [click on my link](#), sign up and complete an offer like I did (Stamps.com, or Netflix, ...).

9/ Once I have 13 people under me, I will have to let the company know that I have my 13 people, thus I am eligible for the free iPhone.

10/ The company will check my account to make sure I didn't have my wife or roommate sign up as well and they will ship my iPhone.

That's it! Isn't it simple?

This is risk free!

Note that you don't have to give your SS#, which was a key factor for me. I gave Stamps.com my Credit Card number because I know they are a totally legit company. I will cancel in about 2-3 weeks. I would not recommend cancelling right away or it may look suspicious. Wait a few weeks.

The full item and shipping costs are covered by your earned points and you will never receive a bill, invoice, or charge from us for your item or shipping cost (Please review the advertiser registration terms to determine any recurring service(s) regarding your account with them).

12. Individuals participating with a referral account are encouraged to seek others to sign-up beneath them to obtain their free gift, however, "spamming" is not permitted and is a violation of this agreement. Users who engage in spamming will have their accounts closed.

13. Users may not transfer accounts to any other person.
